Additional Information:

1. Live Entertainment Permits are granted for one-year terms (Section 5.28.110 MHMC).
2. Must notify Chief of Police with any changes to staff operating or assisting in the operation of your business/organization OR any other changes to the information submitted on the permit application.
3. The chief of police may, by written notice, revoke or suspend the permit of any person holding same in the city, upon receiving satisfactory evidence that the permittee has failed to comply with the provisions of this chapter, specifically those listed in Section 5.28.080, has failed to comply with the conditions specified on the permit or any other conditional use permit, entitlement or license which regulates the establishment, or the permittee, or employees of the permittee, are engaged in conduct or behavior at the premises which creates unreasonable noise or constitutes a nuisance.
4. The Business/Organization and their guests/participants must comply with all State of California and County of Santa Clara COVID Guidelines and Restrictions, including those pertaining to their specific type of business or organization.
